Meeting Minutes of 3/20/17: Approved as submitted.

Opportunities for the Conservation Commission:

- Mapping Your Community's Conservation Resources webinar, April 25 @ 12:30pm, presented by VT Fish and Wildlife.
- Grant opportunity: Town Forest Recreation Planning Community Assistance Program. Up to \$10,000 will be awarded to each of eight Vermont. These funds are used to hire a team of consultants to work with each town to develop a plan for the town forest use. Deadline for application is 6/1/17. Towns will be notified by August 8, 2017 of the application outcome.

 - Request letter of support from Selectboard

Green Up Day, May 6: Kerri Rogers is spearheading this event.

As requested, the Conservation Commission has been unappointed as the coordinating agency for Green Up Day.

Mike Bald, as a private citizen, advised White River Partnership and the Selectboard that Japanese Knotweed spread by Irene is now established and entering rapid expansion phase from his expertise. Now that the Knotweed has been well established it is time to consider what to do with it. The Conservation Commission heard from Mike Bald, understanding that the Japanese Knotweed is becoming a big problem along the riverbanks. This can create safety hazards and infrastructure damage. ***The commission has accepted Mike Bald's input and advises the town to think about future management work, at least by determining which areas in town are most important.*** Brad will write a short letter to the Selectboard regarding the Japanese knotweed problem.

Bylaws: Work on the bylaws continued focusing on details regarding commission membership. Brad will integrate details into the draft bylaws. We will continue to review our bylaws at the May meeting.
