Meeting Minutes – Draft
February 19, 2018

Welcome/Introductions

Visitor: Noel Dodge, Fish & Wildlife Dept., Regulatory Reviewer, Sarnoff Property, Deer Wintering Habitat

Call to Order: 6:35 pm

Sarnoff Property: Deer Wintering Habitat: Noel Dodge

- Noel Dodge, Regulatory Review Biologist for State of Vermont. Presenting information regarding proposed solar project at the Bethel-Royalton Transfer Station. Discussed that the developer and project are currently working through ACT 248 permitting process.
- Proposed Solar project at transfer station includes impact of 0.8 acres of deer wintering area. Solar project developer is requesting to off-set (mitigate) the deer wintering area impact by conserving deer wintering area on the Sarnoff property. The solar developer is offering to pay for the land management plan updating of the Sarnoff property and to include the mitigation effort of the solar project by restricting recreational use of a portion of the Sarnoff property during the winter.
- Note: there was confusion of the exact amount of land described to be restricted for recreational use during the winter months. Follow-up will be required to clarify the amount of land to be restricted. The Royalton Conservation Commission (RCC) was planning to further investigate this land for recreation use during the winter and would like to not give away the potential for winter recreation use at this time.
- Noel described that the solar project developer's alternate option for mitigating the impact at the transfer station would be to obtain a permanent easement on other deer wintering areas, which would cause additional costs to the solar project.
- Discussion and understanding the on-site mitigation requires a 2:1 ratio for conserved deer wintering area to impacted deer wintering area. Discussion and understanding that off-site mitigation requires a 4:1 ratio for conserved deer wintering area to impacted deer wintering area.
- Some discussion regarding the intended work by AJ, County Forester, for updating forestry assessment and then getting recommendations for tweaks with few things on plan.
- Discussion that AJ, Planning Commission, Conservation Commission and Selectboard would all need to sign off on any land management plan amendments. Noel Dodge would oversee.
- Discussion that Sam Carlson, Green Lantern Solar, the developer, met with SR planning board and there was no opposition to winter recreation restrictions on the Sarnoff property.
- Discussion of the ACT 248 process and conditions for permitting by solar developer. Discussed that plan will be signed off by Town Selectboard, Planning and Conservation committees.
- Noel discussed F&W would like to have NO winter recreation (from December through Spring?) Discussed winter biking, snowshoeing, and cross-country skiing causes more impact to deer population during the winter than snowmobiling due to low noise and the nature of startling the deer while cross-country skiing, winter biking or snowshoeing.
- Some discussion that Recreation may be allowable on railroad bed trail only.
- Discussion that a request to the developer may include having the developer pay for any signage required to properly sign a potential conserved deer wintering area and provide updated signage through the life of the conservation agreement.
- Noel discussed the project construction is anticipated for Summer 2018. RCC discussed that an on-site review in April should be planned to prepare for review of an updated land management plan.
- Noel and RCC discussed that the developer is already working on the land management plan. RCC discussed that at this point if the updating of the land management plan is in progress, we will await the draft to see what the plan says.

- RCC discussed process, Selectboard and Planning board did not consult RCC. Discussion RCC needs to follow-up/report more to other boards.
- RCC will reach out to the Selectboard and planning board that we would like to review the plan before it is accepted.
- We would like to walk the Sarnoff property when it is walked by AJ, Windsor County Forester, Noel Dodge, Fish & Wildlife, State of Vermont, and/or developer Green Lattern Solar. We ask all the parties to let us know when that will be happening.
